District Leader's Report

Leaders

This year the only office of any consequence on the ballot will be Democratic District Leader, but I write this month of our higher leaders, who have had an especially eventful couple of months, rated herein with positive or negative stars:

Obama **** Our President gave one of his, and our country's best, State of the Union Addresses, eloquently and forcefully claiming that the credit for our significant economic recovery is due to the economic policies he and the Democrats have pursued. We need more, not less of these policies: more spending for infrastructure and education, more efforts to combat human-caused global warming, more undoing of tax loopholes which favor the rich and produce no jobs. If I quibble with any of the President's speech, it's that he stop talking so much about the deficit—which he has reduced by two thirds—and raising taxes for the rich to pay for middle class tax cuts. This "my tax cuts are better than your tax cuts" approach plays into the hands of the conservatives. We should not be stressing any tax cuts; the best way to create jobs is not through tax cuts, but through spending on infrastructure and the environment.

De Blasio ** Our Mayor has successfully pursued many worthwhile initiatives, from Pre-K to affordable housing. Unlike the dreadful PBA head Lynch, he handled the events surrounding the tragic murders of police officers Wenjian Liu and Rafael Ramos with intelligence, dignity, and restraint. Bad cops such as Eric Garner's assailant Daniel Pantaleo destroy the lives of families, undermine people's faith in law enforcement, cost the city millions of dollars in legal settlements, and ultimately do a disservice to

the vast majority of good cops who understandably but incorrectly come to the defense of their erring colleagues. My one major criticism of Mayor De Blasio is in his mulish (pardon the pun) attempts to ban carriage horses in Central Park. This policy, fueled by real estate money which funds the unethical organization NYClass, starts from a general premise which is preposterous—it is not inhumane for horses to pull carriages, that is what they do!—and follows with a specific untruth: these particular horses are not mistreated, vet after vet has testified how well treated they are. The one legitimate cause for concern, the horses' trip through city streets from the stables to Central Park, is blown way out of proportion. There have been exactly three Central Park carriage horse traffic fatalities in the last 70 years, hardly a reason to destroy something that has employed thousands, brought joy to millions, and is a lasting and positive link from our city's past to its future.

Cuomo + *** and -** The best recent policy taken by any US executive was Governor Cuomo's banning fracking in New York; one of the loveliest speeches of this year or any year was Andrew Cuomo's tribute to his father Mario. But then we have the Governor's cavalier and ultimately erroneous ignoring the Mayor and closing the subways in the face of a storm that produced less than 4" of new snow. Worst are the education policies: even if you think that Charter Schools are great, even if you just love the idea of firing a few hundred more teachers a year, these are extremely minor aspects of education policy. When the UFT was supporting a truly outrageous policy, allowing teachers with seniority to "bump" popular established teachers from their classrooms, virtually everyone said this was terrible, and the practice was (mostly) stopped. But on Charters and teacher tenure, the Continues on next page Governor is listening only to voices with their own, generally money-driven agendas. Listen before you speak, Governor Cuomo, as you did on fracking and on your beautiful tribute to your father.

Silver -*** The former Speaker ably led one of the most progressive legislative bodies in the country for more than 20 years. But, legally guilty or not, he clearly enriched himself by encouraging people with business before the State to become his and his firm's private law clients. Broadway Democrats was founded in the later part of the New York City reform movement; Franz Leichter is probably our only surviving link to this movement's early days in the 1950's. Sure, reformers, like anybody, can be holier than thou, but the changes they fought for, for openness in government, against the corrosive effects of money on politics, are as important now as they were then. No matter what his legislative accomplishments, Sheldon Silver let us down. His successor has got to do better.

Boehner and Netanyahu -**** Israel has come under attack, most of it I believe unfair, for its attempts to defend itself against the terrorist organizations Hamas and Hezbollah. The Obama Administration, as it should have, has defended Israel every single time it has been attacked, too often being the only country in the world to come to Israel's defense. When your civilians are under attack, when your very survival is threatened, should you seek out more allies, and try to work even more closely with your closest and strongest ally, or should you further alienate potential new allies and at every turn try to undermine and defeat the leaders of the only real ally you have? Should be an easy choice, right? Not for the perverse right wing leader of Israel. He constantly undermines President Obama, preferring to ally with right wing legislators in the U.S. who command no troops, and to pander to right wing religious settlers in Israel who refuse to fight. As for Boehner, there is only one word for someone who attempts to subvert his country's leader, over an issue that could lead to nuclear war. That word is treason.

At the state level, the recent arrest of former Assembly Speaker Sheldon Silver is going to have a substantial impact on the business of the State Legislature. With Republicans once Continues on next page

again in control of the State Senate, a strong progressive voice is needed in the Assembly to counteract the conservatives in the Senate and the centrist tendencies of the Governor. As always, we can rely on our Assemblymember Daniel O'Donnell to be a stalwart force on behalf of progressive values in Albany. We can only hope the new leadership in the Assembly will follow Danny's example.

In Washington, Democrats must be prepared for a long two years. With Republicans firmly in control of both houses of Congress, there is very little chance of any legislation being passed that will actually produce positive benefits for the country. Instead, we can expect Republicans to seize every opportunity to attempt to undo the accomplishments of the last six years. Real Rent Reform 2015 - our last best chance to preserve rent stabilization in New York City

City Councilman Mark Levine's Housing Forum on January 28 was packed. "Housing is the number one issue in District 7", said Levine. "Last year the city had 30,000 evictions and up to 60,000 homeless people per night. Of these, two thirds are families and 25,000 are children."

Many of the attendees, myself included, are currently experiencing the phase-out of rent-and eviction protections. And yet, 2015 presents a real opportunity to demand the reversal of the law that brought on this tide of destabilization.

As we all know, when the lease for a rent stabilized apartments reaches the threshold of \$2500, the apartment is considered "luxury" and no longer subject to rent regulations. It provides an irresistible incentive for landlords to push long-time tenants out of their properties. There are renters who are able to pay two and three fold the amount of rent. Public Advocate Letitia "Tish" James assured the attendees that she is "all lawyered up" and ready to fight for rent laws that secure affordable housing. Ironically, our City elected officials do not have the power to legislate City rent laws. They are decided in Albany.

So what is the opportunity? Number one: On June 15 the current rent laws will expire. Number two: After many years, we have elected City officials who are willing to fight for tenants' rights. According to the website of R3/Real Rent Reform, "Bill de Blasio...has promised to fight for home rule and repeal of vacancy destabilization, and to go to Albany with tenants to press that agenda."

The day to go to Albany is February 10. Buses will be available for a day of lobbying. For details on this event and other related events go to: www.realrentreform.org. The website lists upcoming local events. There will be more. The moment is ours to seize!
